On 10-19-2011 at approx. 11:22 pm I was dispatched to 1920 S. River Rd. Apt. A in ref. to information about the escaped monkey from the Kopchak Rd. area. Upon arriving at that address I spoke with the comp. Heather D. Spears. Heather stated that she was on Craig's List earlier and discovered that a posting was placed stating that a monkey was for sale in the Zanesville area. Upon clicking on this post, Heather discovered that the posting stated that the person attempting to sell the monkey claims that they found the monkey in their garbage, found it to be very cute, and decided to keep it. The posting went on to say that the monkey was too much to take care of because it was wiping feces all over the walls and throwing feces, therefore, they were attempting to sell it for \$10,000. The posting also mentioned that the monkey acted as if it was wanted by law enforcement and provided an email address for anyone to contact if interested in this monkey. The email address is as follows: sale-dfzxa-2658762871@craigslist.org. The posting was placed on 10-19-2011 at 7:48 pm. Heather viewed this posting on her cell phone and felt that it was odd and that she needed to contact the sheriff's office and report it.

After leaving the comp. residence, I then proceeded to Musk. Co. dispatch where I attempted to locate the ad on the in-house computer. The add has since been removed, however, a second ad had been posted with the title: Monkey that escaped - \$999999 (Zanesville). The posting states, "if you happen to find a monkey laying around, such as the one that escaped, capture it and give it to me.." This posting was posted to Craig's List on 10-19-2011 at 12:11 pm with an email address to reply as followed: sale-w6dss-2657842723@craigslist.org. The posting for this ad was printed off and attached with this report. The first posting showing that the monkey was for sale had been removed from Craig's List and was unable to be printed out.
